# Surveying the landscapes of Dubai's urban model



## How are landscapes used as a tool for political legitmisation in Dubai?



• This book 'Desert Paradises: Surveying the Landscapes of Dubai's Urban Model' explores how designed landscapes can play a vital role in constructing a city's global image and legitimising its socio-political hierarchy. Using the case study of Dubai, the book explores how Dubai's rulers employ a paradisiacal image of greening the desert, in part as a tool for political legitimisation.

• 'Desert Paradises' also evaluates the designed landscapes of Dubai against the principles of the United Nations and the International Federation of Landscape Architects and argues that what is happening in Dubai represents a significant discrepancy between theory and practice.

• This book offers a new perspective on landscape design that has until now been unexplored. It would benefit academics and students interested in Dubai or the many cities in the region experiencing Dubaification.
